

Second display of Publication of Information for assessment of Preliminary Documentation for the Proposed Residential Development of 145 Rossiter Road, Koo Wee Rup, VICTORIA (EPBC 2023/09694)

The following notice is published pursuant to Section 95B (2) of the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act).

The proposed residential development — “the proposed action” — will occur at 145 Rossiter Road, Koo-Wee-Rup, Victoria (Lot 2 PS 321029K). Rossiter Road Investments Pty Ltd engaged Nature Advisory Pty Ltd to prepare an assessment of the impacts of the proposed action on relevant Matters of National Environmental Significance (MNES) listed under the Commonwealth *Environment Protection and Biodiversity Conservation Act 1999* (the ‘EPBC Act’). A referral under the EPBC Act has been submitted to the Commonwealth Department of Climate Change, Energy, the Environment and Water (DCCEEW) for the proposed action, which was deemed a controlled action. Subsequently, an Environmental Management Plan for the creation of new habitat onsite for Growling Grass Frog and Southern Brown Bandicoot was prepared and submitted to DCCEEW.

The relevant Matters of National Environmental Significance (MNES) protected by a provision of Part 3 of the EPBC Act are:

- Listed threatened species and communities (Sections 18 and 18A) - Growling Grass Frog *Litoria raniformis* and Southern Brown Bandicoot *Isodon obesulus obesulus*.

The proposed action was determined to be a Controlled Action under the EPBC Act on 16 February 2024 due to the potential for a significant impact on a threatened fauna species - Growling Grass Frog and Southern Brown Bandicoot.

On Thursday 22 May 2025, the Preliminary Documentation package had been placed on display for public comment until COB Wednesday 4 June 2025 (10 business days). All comments received were summarised and a response was submitted to DCCEEW.

The final Preliminary Documentation has been amended and will be published for information purposes only.

On Wednesday 27 August 2025, this notice has been published in a national daily newspaper (The Age) and a local newspaper (Pakenham Gazette).
